Dear Mr. Brice:

Mayor Willie Brooks Webster asked me in a letter on March 7, 1986, to head a history committee for the purpose of gathering facts on the town of Fairmont. He wished that these facts be made available by 1987 for the Robeson County Bi-centennial celebration.

Upon acceptance, I called upon the following individuals and they agreed to serve with me:

Ms. Nell Floyd

While others were asked, they chose not to serve or to take a more active role. However, some have furnished valuable information. This committee has met since June, 1986, appropriately in the old Atlantic Coastline depot. Although we have not met every month, we have exchanged a lot of information.

In our search for information, the town office has been most cooperative. Unfortunately, records from the early years of Fairmont's history have been misplaced or destroyed. Therefore, this has been a program of research into secondary documents, as well as tracing down old verbal stories.

So that the citizenry of Fairmont and South Robeson may help us "fill in the gaps" for many of the lost years, the history committee would like to set up a booth for the upcoming Farmers' Festival for the purpose of displaying old pictures and other memorabilia. We will make ourselves available to anyone who has some history to "pass on." We need to finish this compilation so that by February 27, 1999, when we celebrate our town's centennial, we, hopefully, will have a complete and accurate history. In the meantime, we will have all "known history" at this time, and the Schedule of Events for the day of the festival, ready for publication by August 8.

As you have heard, this area has been known as the Ashpole Community for a long

time. To set the record straight, this writer does not know how the name Ashpole was derived. There is much speculation but nothing of any substantial proof. We do know that the Ashpole Swamp extends below the South Carolina line, and starts beyond Highway 301, west of Seaboard Coastline Railroad, and Elrod. According to the records at the Robeson County Court House, the earliest deed, written in November of 1753, records a 100-acre tract of Joseph Dawson, and uses the landmarks of: south of Drowning Creek, (Lumber River) and north of Ashpole Swamp.

The name of "Ashpole" has been used in South Robeson by various organizations and churches such as: 1792-Ashpole Presbyterian Church; 1825-Ashpole Baptist Church; Ashpole Academy-1874; Ashpole Lodge #335-1875; Ashpole Institute-1878; Ashpole Center United Methodist Church (1880); The town of Ashpole (Fairmont)-1901; Ashpole Lodge #528 (1904); Ashpole Elementary Center School (1926); and Ashpole Trading Company (1971); Bank of Ashpole-1904.

After a number of years this community known as Ashpole became known as Union City. This was due to the Private Laws Act of North Carolina which reads as follows:

Session 1899 Chapter 112

An Act to Incorporate the Town of Union City, in Robeson County.

The General Assembly of North Carolina do enact:

Section 1. That the village now known as Ashpole in Robeson County, be and the same is hereby incorporated under the name and style of "Union City" and shall be subject to all the provisions of chapter sixty-two (62) of second volume of The Code of North Carolina.

Section 2. That the corporate limits of said town shall be as follows, viz: Beginning at the point where the Inman and Ionia roads intersect and runs north one-half mile; thence east one-half mile; thence south one mile, thence west one mile; thence north one mile, thence east one-half mile, making one mile square.

Section 3. That the officers of said town shall consist of Mayor, five aldermen, a marshal and a clerk and treasurer.

Section 4. That until their successors have been duly elected and qualified, the following named persons shall fill said offices, towit: Mayor, Robert E. Lee; aldermen, Dr. John P. Brown, Charles B. Thompson, Prof. G.E. Lineberry, A.L. Jones and A.A. Floyd; clerk and treasurer, F.S. Floyd; marshal, Henry G. Braswell.

Section 5. That there shall be an election held on the first Monday in May, eighteen hundred and ninety-nine, and annually thereafter for said officers under the rules and regulations governing other elections in North Carolina.

Section 6. That whenever a vacancy occurs in said offices the aldermen shall appoint one of their number mayor pro tem.

Section 7. That the aldermen of said town shall have power to pass ordinances, rules and by-laws for the government of the town not inconsistent with the laws of the state of North Carolina and of the United States.

Section 8. The mayor is hereby empowered with the right to impose fines and penalties for the violation of the ordinances established by the aldermen of said town.

Section 9. That all fines collected for the violation of the ordinances established by the aldermen for the government of said town shall be paid into the treasury of said town for the use and benefits of said town.

Section 10. That the treasurer and marshal shall each be required to enter into a bond in the sum of two hundred dollars (\$200.00) for the faithful performance of their duty, payable to the State of North Carolina, subject to the approval of the board of aldermen of said town.

Section 11. That the manufacture and sale of all spirituous, vinous and malt liquors, wine and cider are hereby prohibited.

Section 12. That all laws and clauses of laws in conflict with this act are hereby repealed.

Section 13. That this act shall be in full force and effect on and after its ratification.

Ratified the 27th day of February, A.D.,

As noted in Section 4 of the previous act a number of qualified citizens were appointed to serve as town officials. The following is a brief summary of what we have found about these early town officers.

Robert Edward Lee: Appointed as the first Mayor of Union City. Born December 12, 1874 and died September 17, 1936. Son of William O. Lee and Leah Hassey Lee. Raised in the Lee place which was located in front of the present day Lynn Floyd home on Hwy 130 west of Fairmont. Had connection with a newspaper in Elizabethtown; member of the Robeson County Bar and practiced law in Lumberton for a number of years. Was also Fairmont Legal Counselor during that time. According to his family, his term of office was short.

Comm. John Powell Brown: Born April 13, 1864. Died December 7, 1941. Born in Leesville community - P.O. established 1827 (out near where present day Francis Floyd lives on Old Stage Road.) Son of Dr. John Burton Brown and Martha Ashley Brown. Was a doctor for the Atlantic Coastline Railroad; realtor; businessman.

Comm. Charles B. Thompson:

Professor G.E. Lineberry: (Heresay)
Taught at the Ashpole Institute and went to
the North Carolina School of the Blind as
headmaster.

Farmer, born Aug. 29, 1855, died July 8, 1927.

Comm. Alford Lafayette Jones: Born December 20, 1860. Died August 15, 1921. Alford Jones came to Fairmont about 1897 and was the owner of Southeast Lumber Co. He was one of the pioneers in the building of Fairmont. Jones built the Southeastern Railroad Co.; was the main factor in building the Fairmont Tobacco Market and was owner of the Fairmont Tobacco Warehouse: Vice President of the Fairmont Supply Co.; a former President of the Fairmont Light and Power Co.; President of the Fairmont Redrying Plant until its purchase by the Imperial Tobacco Co. of Great Britain and Ireland; a shareholder in the New National Bank; a farmer and a real estate dealer.

Comm. Augustus A. Floyd:

Farmer. Born April 1, 1886, died May 28, 1912.



F.S. Floyd: Clerk and treasurer. Henry G. Braswell: Marhsal. (Buried in Baptist Cemetery). Born 1874 - died 1904. Post Master: Andrew Justin Floyd.

Public Laws of North Carolina 1899

Chapter 176. An act to alter the dividing line between White House and Britt's townships, in Robeson County. Union City was in White House Township.

The General Assembly of North Carolina do enact:

Section 1. That the dividing line between White House and Britt's townships in Robeson County be altered so as to run to Hog Swamp to the point where Red Hill branch runs into Hog Swamp; then up Red Hill branch to the line of Hill estate — — with the diving line between Miss Rosa Ashley's land and the lands of the Hill heirs to the run of miry branch; then with the run of Miry branch to the old field swamp, present line of White House township, so as to include the Ashley and Pitman positions in White House township.

Section 2. That this act shall be in force from and after its ratification.

Ratified the first day of February, A.D. 1899.

Feb. 27, 1899 - We know that the following were appointed officals, and that they served until May 1, 1899.

On May 4, 1900 (which was the first Monday) there was an election. At this time, James Hardy Allen Inman was elected Mayor. According to the 1900 census, which was enumerated on June 2, 1900, Mr. Inman was the town Mayor. It is unknown who the commissioners were.

PRIVATE LAWS OF NORTH CAROLINA SESSION 1901 CHAPTER 82

An Act to Change the Name of the Town of Union City to Ashpole and to Amend the Charter Thereof.

The General Assembly of North Carolina do enact:

Section 1. That the inhabitants of the town of Union City shall continue to be a body corporate under the name and style of the "Town of Ashpole", and under such name is hereby invested with all the privileges, immunities and franchises, property and all other rights heretofore belonging or appertaining to the town of Union City, and in and by that name may sue and be sued, plead and be impleaded, acquire and hold property, real and personal, for the uses of the town as its Board of Commissioners may deem necessary and expedient.

Section 2. That Dr. J.P. Brown shall be Mayor and C.B. Thompson, C.T. Cashwell, J.M. Ashley and Dr. W.F. Stephens shall be Commissioners, and W.C. Brown shall be Town Clerk and Treasurer, and William Prevatt shall be Town Constable, and the same are hereby declared the Mayor, Commissioners, Constable and Clerk and Treasurer, with the power and duties of the duly qualified officers of the town of Ashpole, until their successors are elected and qualified as hereinafter provided.

Section 3. That the corporate limits of said town shall be and are hereby declared to be included within the following boundaries, to wit: Beginning at a point one-half mile due north of the intersection of the Inman and Iona roads in the present town of Union City, and runs due east one-half mile, thence due south one mile, thence due west one mile, thence due north one mile, thence due eastr one-half mile to the beginning so as to form a right-angled parrallelogram with the intersection of said roads as a center.

Section 4. The officers of said town shall consist of a Mayor and four Commissioners, to be elected by the qualified voters of said town annually on the first Monday in May.

Section 5. Said election of Mayor and Commissioners shall be held at the mayor's office in said town and no person shall be entitled to vote at said election or at any election held in said town for municipal purposes, unless he shall be an elector of the State of North Carolina, under existing laws

and shall have resided ninety days next preceding the day of election within the said corporation.

Sections 6-58 have been omitted due to lack of space. Anyone interested may read those sections at the Fairmont Town Office.

In the General Assembly read three times, and ratified this 8th day of February, A.D. 1901.

CHAPTER 42

AN ACT TO CHANGE THE NAME OF THE

TOWN OF ASHPOLE, IN ROBESON COUNTY, TO FAIRMONT.

The General Assembly of North Carolina do enact:


Section 1. That chapter eighty-two (82), Private Laws of the General Assembly of North Carolina of one thousand nine hundred and one, be and the same is hereby amended as follows, to-wit: Strike out the word "Ashpole," whenever used in said chapter and insert in lieu thereof the word "Fairmont."

Section 2. That the name of the town of Ashpole, in Robeson County, is hereby changed and shall hereafter be known as "Fairmont."

Section 3. That the act incorporating the town of Ashpole, together with all acts amendatory or supplementary thereto, shall apply to the town of Fairmont.

Section 4. That all laws in conflict with this act are hereby repealed.

Section 5. This act shall be in force from and after its ratification.



In the General Assembly read three times, and ratified this the 7th day of February, A.D. 1907.

How the Name "Fairmont" was Chosen (Taken from the Fairmont Messenger, August 13, 1914)

"Fairmont is a comparatively new town having only borne the name Fairmont since 1907. The derivation of the name is due to the efforts of Mr. F.L. Blue who was mayor at the time. He set out to find a name that would be suitable to the towns location. He found where Fairmont in Davidson County had discontinued a post office. He then directed the town's attorney to have the Charter amended and the town's name changed to Fairmont."

A Rose

(Taken from the Fairmont Messenger, June 9, 1910)

"The people of Fairmont are anxious about the future name of their community. It will be remembered that the post office was abolished when the rural route reached

the town, and while the place remained Fairmont as it had been for many years, the name disappeared from the postal department's list. Sometime afterward the village of Ashpole, in Robeson County, decided that it didn't want to be called Ashpole any longer, and applied to the department for a new name, and Fairmont it was christened. Now that the Southbound is being built through the Davidson County, Fairmont, the citizens dream of building up a thrifty town, and naturally want to hold on to the old name. They will be wanting a post office of their own again, and its name must be Fairmont. They say they will take the matter up with the department and appeal to Congressman Page and Senator Overman to help them out.

The above is from the Lexington Dispatch and right here we wish to say that if the Davidson county Fairmont went to sleep and let our wide-awake town, no longer village if you please, take her name, why she will have to get another and content herself with the reflection that "A rose by any other name would smell as sweet."

PRIVATE LAWS 1913

CHAPTER 308

AN ACT TO AMEND CHAPTER 82, PRIVATE LAWS OF 1901, ENTITLED "AN ACT TO CHANGE THE NAME OF THE TOWN OF UNION CITY TO ASHPOLE AND TO AMEND THE CHARTER THEREOF."

The General Assembly of North Carolina do enact:

Section 1. That section three of chapter eighty-two, Private Laws of one thousand nine hundred and one, be so amended as to read as follows: That the corporate limits of said town (now the town of Fairmont: see Acts of one thousand nine hundred and seven) shall be and are hereby declared to be included within the following boundaries, to wit: Beginning at a point three-quarters of a mile due north of the intersection of Main and Iona Streets (formerly Inman and Iona roads) in the present town of Fairmont and runs due east one-half mile; thence due south one and one-quarter miles; thence due west one mile; thence due north one and one-quarter miles; thence due east one-half mile to the beginning, so as to form a right angled parallelogram with the dimensions one and one-quarter miles by one mile.

Section 2. That all laws in conflict with this act are hereby repealed. That this act shall be in force from and after its ratification.

Ratified this the 5th day of March, A.D. 1913.

CHAPTER 149

AN ACT TO AMEND CHAPTER 343 OF THE PRIVATE LAWS OF 1907, RELATING TO THE CHARTER OF THE TOWN OF LUMBERTON AND MAKING THE SAME APPLICABLE TO THE TOWN OF FAIRMONT, N.C.

The General Assembly of North Carolina do enact:

Section 1. That chapter three hundred and forty-three of the Private Laws of one thou-



sand nine hundred and seven be amended by adding at the end of section thirty-one of said chapter the following: "That all the provisions of section thirty-one shall apply to the town of Fairmont, North Carolina, and all primary elections in said town of Fairmont shall be conducted in accordance with the provisions of said section thirty-one; and wherever in said section thirty-one there occurs the words 'The Town of Lumberton,' there shall be added immediately following the words 'and the Town of Fairmont."

Section 2. That all laws and clauses of laws in conflict with this act be and the same are hereby repealed.

Section 3. That this act shall be in force from and after its ratification.

PRIVATE LAWS 1921

CHAPTER 64

AN ACT TO EXTEND THE TOWN LIMITS OF THE TOWN OF FAIRMONT (FORMERLY ASHPOLE) AND TO AMEND THE CHARTER THEREOF.

The General Assembly of North Carolina do enact:



Section 1. That chapter eighty-two of the Private Laws of North Carolina, session of one thousand nine hundred and one, be and the same is further amended by adding at the end of section three thereof the following: "The following territory lying next adjacent to the foregoing boundaries shall also be embraced within the corporate limits of the said town, and form a part thereof: "Beginning at the northeast corner of the town of Fairmont and running west along the town line three thousand four hundred eighteen feet to a line of shade trees on the lands of the Beaufort County Lumber Company on the east side of a street heretofore opened and maintained by said company, thence north three degrees west and beyond said line of shade trees one thousand one hundred eighteen feet to a point in B.M. Lewis' lands; thence east three thousand four hundred eighteen feet; thence south three degrees east to the beginning corner."

Section 2. That all statutes heretofore enacted by the General Assembly, or which

may hereafter be enacted amending the charter of the said town of Fairmont, or otherwise pertaining to said town, shall have the same application to the extension of said town as herein described as if the same had originally been included within the corporate boundaries of the said municipality.

Section 3. That all laws and clauses of laws in conflict with this act be and the same are hereby repealed.

Section 4. That this act shall be in force from and after its ratification.

Ratified this the 25th day of February, A.D. 1921.


